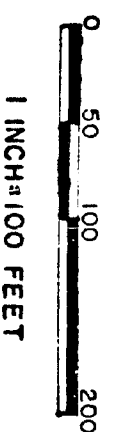

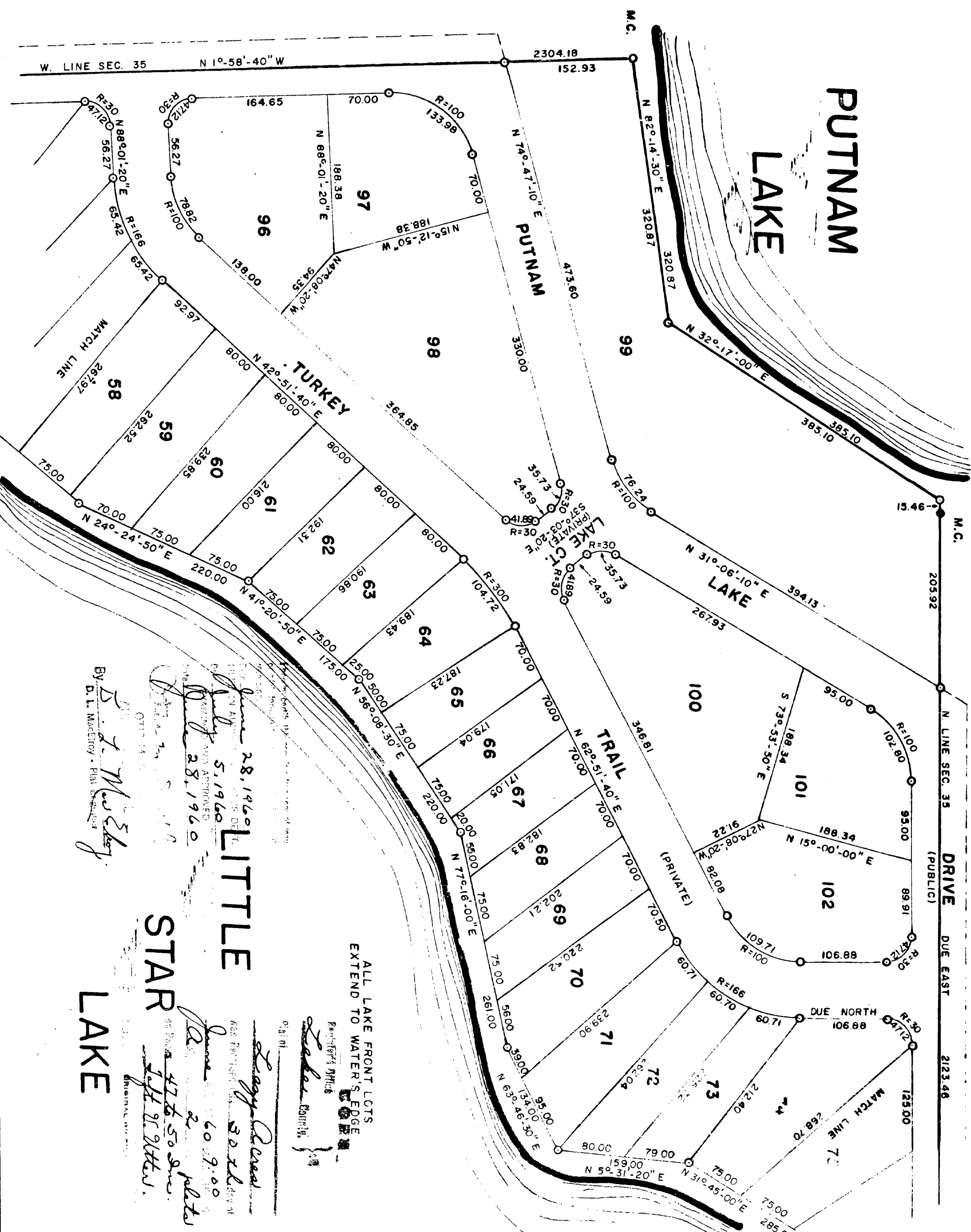

DESCRIPTION:
The land embraced in the annexed plat of LAZY ACHES, the NW 1/4 of Sec. 35, T18N R13W Webber Twp., Lake Co., Mich., is described as beginning at the N 1/4 Cor. said Sec. 35 T18N R13W, thence S 1°-05'-40" E along the N-S 1/4 line 2648.88 feet to the Center 1/4 Cor. said Sec. 35 T18N R13W, thence S 89°-29'-20" W along the E-W 1/4 line 2818.02 feet to the W 1/4 Cor. said Sec. 35 T18N R13W, thence N 1°-58'-40" W along the west Sec. line 2304.18 feet to the Meander Cor. on the South end Putnam Lake, thence N 82°-14'-30" E 320.87 feet, thence N 32°-17'-00" E 385.10 feet, thence Due East 2123.46 feet to the Point of Beginning.
Plat contains a total of 102 lots.....

SURVEYOR'S CERTIFICATION:

Iron pipes one-half inch in diameter and eighteen inches in length have been placed at all points marked thus (P) as shown on said plat.

EXTEND TO WATER'S EDGE

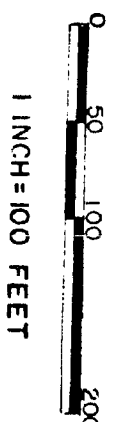

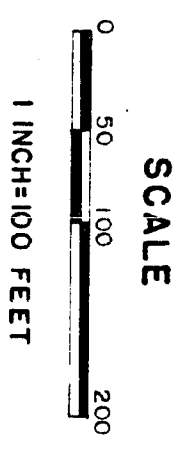

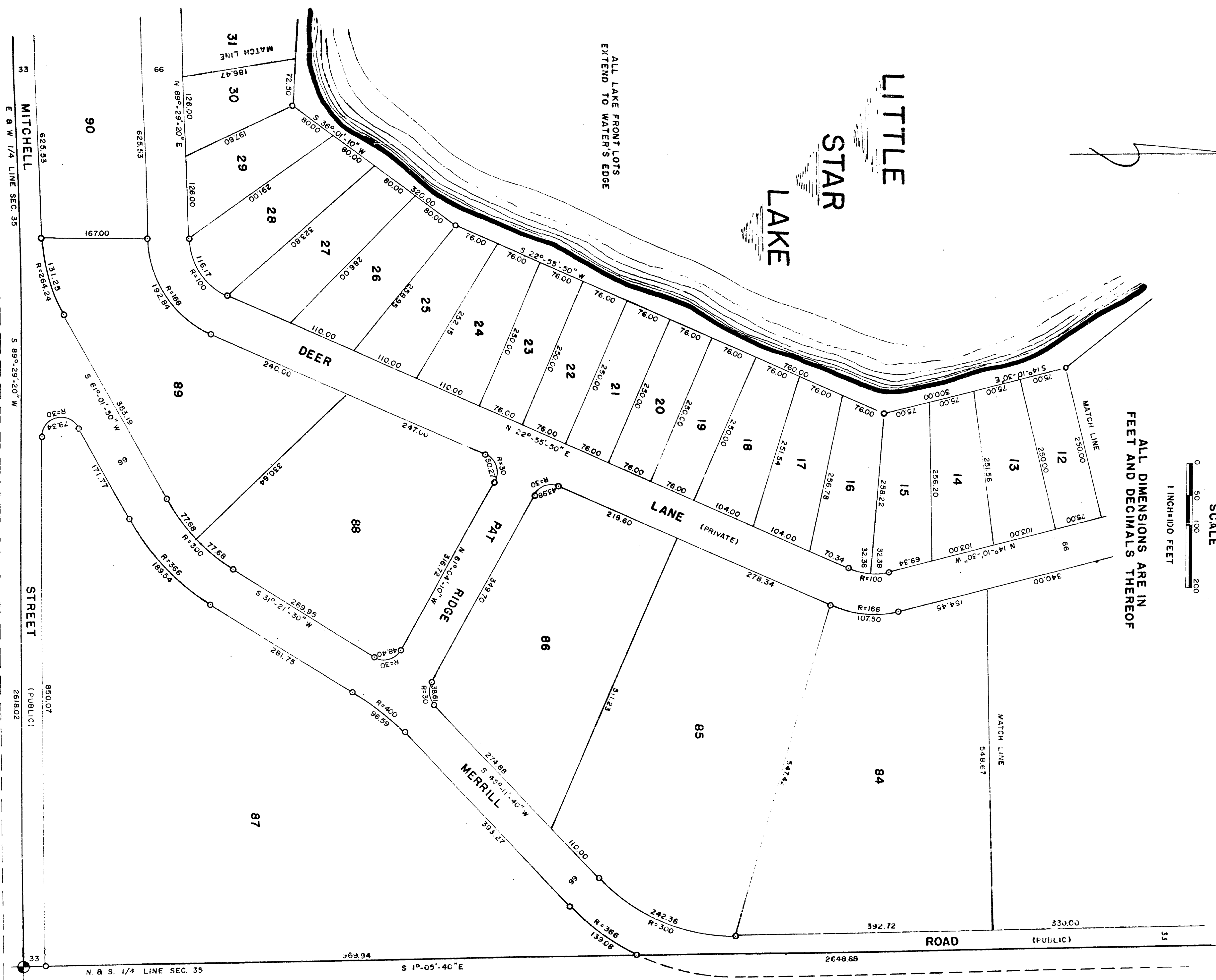
