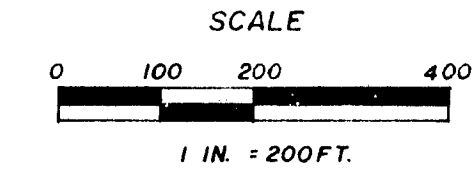
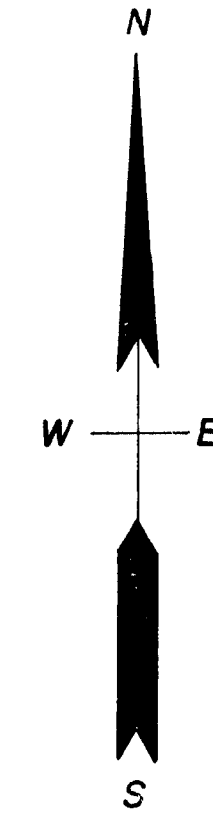

Lake Co., Mich. is described as beginning at a point on the N.S. 1/4 line of said sec. S0°30'45"W 33.01 ft. from the N. 1/4 cor. of said sec., thence S87°55'03"E parallel with the N. line of said sec. 1320.47 ft. to the E. 1/16 line of said sec., thence S0°29'26"W along said E. 1/16 line 1331.65 ft. to the N. 1/16 line of said sec., thence N87°00'20"W along said N. 1/16 line 1477.67 ft., thence N60°35'14"W 1328.01 ft. to the W. 1/16 line of said sec., thence N0°23'08"E along said W. 1/16 line 698.19 ft. to a point 33 ft. S. of the N. line of said sec., thence S87°55'03"E parallel with the N. line of said sec. 1320.41 ft. to the point of beginning. Plat contains a total of thirty two (32) lots
