PARK RULES

April 13, 2026

- Park hours 8:00 a.m. until 8:00 p.m., unless otherwise designated or posted, (2026 Season Memorial Day to Labor Day)
- All Vehicles must be out of park by 8:00 p.m. (Closing) Park May be closed due to inclement weather
- All vehicles entering the park must be titled and licensed by the Secretary of State
- Riders/Operators under the age of 18 are advised to be accompanied and supervised by a parent or guardian OR have a valid and unrestricted driver's license
- In accordance with MCL 324.81129, all riders/operators under the age of 16 must be accompanied and supervised by a parent or guardian
- With the exception of county training events, in accordance with MCL 324.81120, all riders/operators under the age of 16 must have an ORV Safety Certificate
- 3 wheeler operators must be 16 years of age
- No Parking motor vehicles in area other than designated parking spots
- No operation of remote controlled devices, including drones
- No motor vehicles, ORV's, or related equipment allowed in the park after hours or when park is not open
- No washing of vehicles in parking areas
- Pets allowed only on a leash and in the parking area
- No alcohol or marijuana, or product or substance containing marijuana, or derivatives of tetrahydrocannabinol (THC) use allowed on the property
- No Littering. Garbage is to be placed in the trash receptacles
- Pavilions, picnic tables & benches available on a first come first serve basis, unless specified
- Report Accidents, Injuries, and/or Emergencies to 911
- Reported Emergencies to 911 should include the address of 2374 S M-37 and the area of the park
- Pedestrians are not allowed in any of the training areas
- There are risks involved with ORV use activity at this park
- Riders/drivers should at all time remain in control of their vehicle & limit their speeds to existing conditions
- Speed limits throughout the entire park are limited to 10 mph

ORV's ALLOWED OR PROHIBITED

April 13, 2026

Vehicles allowed in ORV Training Area:

- ATV (Quad): 4 or 6 wheeled vehicle designed for off-road use that has a seat designed to be straddled by the rider
- ATC (3 Wheelers): 3 wheeled vehicle designed for off road use that has a seat designed to be straddled by the rider. 3 Wheelers are not allowed to be operated by persons under the age of 16
- UTC (Side by Side): 4 wheeled vehicle with seating for one to six passengers designed for off-road use
- Motorcycle (Dirt Bike): 2 wheeled vehicle in a tandem arrangement designed for off-road use
- Go-Carts

Vehicles or Activities Prohibited in ORV Training Area:

- Full Sized Automotive Vehicles
- Snowmobiles
- Dune Buggies
- Argos
- Bicycles (Including Electric Bikes)
- Hovercrafts
- Tractors
- Tracked Vehicles
- Snow Bikes
- Horses
- Joggers or Hikers
- Roxor
- Moped

AN INTERNAL COMBUSTION ENGINE OR BY BATTERY POWER***

ORV AND/OR OPERATOR REQUIREMENTS

April 13, 2026

Requirements of ORV and/or Operators

- ORVs must only be operated within the designed ORV training areas. Operators must follow all signage and the directional pattern established within the ORV areas
- All vehicles entering the park must be titled and licensed by the Secretary of State
- All ORVs shall comply with MCL 324.81133 regarding spark arresters and exhaust noise emissions
- All operators or passengers must comply with the provisions of MCL 324.81133 regarding crash helmets, protective eyewear, safety belts, and vehicle roof/roll over protection. Additionally riders are encouraged appropriate protective gear.
- Passengers only allowed in vehicles with designated seating or riding configurations. No Passengers allowed on dirt bikes or ATVs (Quads), unless they are two-ups
- Speeds on the trails should be limited to existing conditions
- Speed limits throughout the entire park are limited to 10 mph
- Riders should avoid passing and be prepared to stop as there may be stalled vehicles or trees/limbs on the trail
- Drive defensively, be careful, stay alert, and in control of your vehicle
- Operators shall limit their speed when entering the trails and training areas
- A person at least 16 years old is allowed to operate a 4 or 3-wheel ATV, a 2-wheel dirt bike, or a side by side in all training areas
- A person at least 12 years old, but less than 16 years of age, is allowed to operate a 4-wheel ATV, a 2-wheel dirt bike, or a side by side in all training areas but must have an ORV Safety Certificate and be supervised and accompanied by a parent or guardian
No 3-wheeled ATV is Allowed at this age - Must be 16.
- A person under the age of 12 years old is only allowed to operate a 2-wheel dirt bike in the Tot Lot or Beginners Loop Areas and must have an ORV Safety Certificate and be supervised and accompanied by a parent or guardian

SAFETY TRAINING AREA

- Employee or authorized personnel only

TOT LOT

ONE WAY TRAFIC

- Target Age - Riders 12 years and older
- Riders under the age of 12 are only allowed on 2-wheeled dirt bikes
- Target Machines - 110 CC's or less
- One Way Traffic
- Inner optional loop with tight turns
- 50" trail

BEGINNER LOOP

ONE WAY TRAFIC

- Target Age - Riders 12 years and older
- Riders under the age of 12 are only allowed on 2-wheeled dirt bikes
- Target Machines - 200 CC's or less
- One Way Traffic
- 50" trail

BEGINNER TRAILS

- One Way Traffic
- Target Age - Beginner Riders and age 12 and older
- Target Machines - 200 CC's or More
- 72" wide trail

SKILLS DEVELOPMENT TRAILS/AREAS

- Includes Man-made Obstacles
- Optional Obstacle By-Pass
- Target Age - Beginner Riders age 12 and older
- Target Machines - 200 CC's or More
- 72" wide trail
- Trails may be designated as two-way
